IV. Main Meeting

A. Approval of Previous Board Minutes

Motion by Von: to approve the May 2016 Board of Directors Meeting minutes.

B. Minister's Report Reverend Mary Ann Macklin

Reverend Macklin is in regular contact with Reverend McNeill.

Splash of the Sacred, an all church picnic and pool party, will be held on August 20.

Congregational leaders and staff will participate in Mosaic Makers, a leadership development initiative that helps congregations in building an intentional multicultural community. The Mosaic Makers workshops will be hosted by the MidAmerica Region in Minnesota. Reverend Macklin encouraged Board members to consider participating. Participants will leave for Minnesota on August 26 and return on August 29. A final count of participants needs to be submitted by the end of June.

Theme based ministry will continue September through December of this year.

A few church members are attending a meeting at Beth Shalom to determine how the Bloomington community will play a part in assisting refugees. Exodus is planning a refugee center in Bloomington. https://exodusrefugee.org/

We continue to be a key location to host memorials for members of the community who are not members of our congregation, who might not otherwise have a location, We value providing this service and it does attract people to our congregation who might not otherwise be aware of us. However, it does stress ministerial and facility

resources due to the growing number of memorials and because the organizers are not familiar with our religion and facilities.

C. Old Business

1. Stewardship Campaign Arzetta

The decreased Sunday plate income was discussed.

In the Fall, enthusiasm around the new minister may bring opportunities for short term stewardship events.

2. Budget Update and Approval Arzetta

Two budgets were presented. The finance committee recommended that we approve the low budget although it includes deep cuts in almost every committee line. There was a discussion about one-time projects that could instead be funded through SPF.

We have not taken large amounts from our operating reserves in the past. If we do not find income to cover the difference between the low budget and our projected income, it will significantly impact but not completely deplete our operating reserves.

Motion by Arzetta: to approve the low budget for 2016-17.

Seconded by Von.

Vote: Unanimously approved.

Arzetta has reviewed where we are in regards to the Fair and Sustainable Compensation Guidelines. She will present a report about our standing at the July Board meeting.
