## I. Call to Order

President Stuart Yoak called the meeting to order online at 7:07 p.m. and welcomed Rev. Dave Clements.

## II. Chalice Lighting and Reading

Abby Gitlitz lit the chalice and provided the reading.

## III. Check-in (All)

## **IV.** Approval of the Minutes

- President Yoak moved for approval of the August 2 special board meeting minutes. After a second, the motion carried with one abstention.
- President Yoak moved for approval of the August 19 regular board meeting minutes. After a second, the motion carried.

## V. Reports

### A. Senior Minister's Report and Motion for Chad Fulk Request

Rev. Mary Ann Macklin delivered the senior minister's report (attachment A), which contains a note from Chad Fulks, currently a death row inmate incarcerated at the federal prison in Terre Haute. The note grants Rev. Bill Breeden the right to sign the UUCB membership book in Fulk's stead, thus allowing him to formally enroll as a member of the UUCB. President Yoak moved that this request for membership be approved by the Board. Drew Schrader pointed out that the specific request being made was not the actual approval of Fulk's membership, but rather for permission for Rev. Breeden to sign for him. The motion was so modified and approved unanimously.

#### B. Interim Consulting Minister's Report

Rev. Dave Clements provided a brief consulting minister's report (Attachment B)

#### C. SPF Committee Report

SPF Chair Andrew Appel reported on changes being made or considered to SPF funds (Attachment C). In all, church investments are holding their own, and in the fourth quarter have returned to the levels they were at prior to the third quarter. Matching funds have been provided through SPF to several community organizations including ReStore and Habitat for Humanity. Ending balances for most funds are now higher than at the beginning of the fiscal year.

#### D. Treasurers Report

Board Treasurer Rich Slabach reported that as of August 31, UUCB remained in good shape considering revenue vs. expenses (Attachment D). Expenses were about \$10,000 below the seasonal average, but with religious education showing a one month jump of about \$6,000. Rev. Macklin attributed this to kickoff activities for the new church year, some consulting for antiracism actions and boxes for RE families and said this was not something that would continue. Rich raised the issue of the policy requirement for a professional audit in 2020 and wondered whether this should be deferred in light of the current situation. Sentiment on the board seemed to run against deferral. Rich will seek a cost estimate for the audit and bring it back to the board.

### VI. New Business

#### A. Board Advance, Sunday Oct. 4

President Yoak suggested the board advance be held at Bradford Woods from around noon to 5 pm or so, the actual schedule to be developed later. An agenda is yet to be set and details would follow. The present plan calls for Rev. Clements to do an icebreaker followed by a middle session dealing with major issues and ending with an executive session.

## VII. Adjournment

The meeting adjourned at 8:30 p.m.

## Reverend Mary Ann Macklin Senior Minister Report to the Board Unitarian Universalist Church of Bloomington September 16, 2020

### **Arrival of Reverend Dave Clements**

It's been a tough journey, but one of growth, love and understanding and this would have not been possible without Rev Bill Breeden and the Unitarian Universalist Church of Bloomington and it's an honor to be a member. # SPF Report 9/17/2020

Good afternoon Steve,

I converted and downloaded the Q3/Q4 report (20B2) and annual report (20C1). 20B2 has been reviewed and approved. 20C1 is a draft, but I've verified the data.

As a summary I would say:

The Board report covering SPF activity for Q3-Q4 of fiscal 2019-2020 is available as is a draft annual report. Investments finished fiscal Q3 with significant losses due to the sharp stock market downturn in March 2020. These losses were primarily, but not entirely, recovered during Q4. Largest SPF expenditures for the back half of the fiscal year were matching funds for Homelessness & Help Feed our Hungry Neighbors Task Force funds being directed to seven local aid organizations and for PPE for Habitat for Humanity to aid in keeping their ReStore facility and build sites safe.

All accounts have been reviewed for the appropriateness of the stock/bond mix. No change will be made in the Endowments which are long term investments and are currently about 7% cash, 64% stocks and 30% bonds. The SPF General, a shorter term spendable account, was also considered adequate at 3% cash, 30% stocks and 67% bonds. \$11,000 will be shifted in the Operational General account from the Wellington Fund to the Vanguard Bond funds to bring that account from 49% stocks to 35% stocks. The final balance will be 4% cash, 35% stocks and 61% bonds. SPF will also be looking at opening a Vanguard Treasury Bond account as a safer haven since the current bond funds have a high percentage of mortgage-backed securities and Vanguard recently removed its 30% limit on the amount of the funds that can be invested in the three lowest investment-grade bond categories.

	At the request of the Board, the SPF Committee assumed investment management and reporting of the Operational General Fund, with the Board retaining expenditure control.									

The Robertson Grounds Endowment and associated income fund were moved from Special Purpose to Operational, better reflecting their use.

Both operational and special surpose assets are now commingled in the same set of investment accounts, with the Committee reports maintaining the division of operational and special purpose assets (as the Committee has long maintained the division of SPF assets between SPF usage funds). This arrangement provides additional administrative flexibility and efficiency.

#### Comments

At Board request, SPFC is now managing investment and reporting of the Operational Endowment and Operational General Fund, which receives the endowment distributions as well as savings. Board maintains control of Operational General Fund expenditures.

The Operational Endowment and General funds have the same investment profile as the Special Purpose Endowment and General funds, respectively. In particular, they all share in proportion to their assets the Wellington fund, checking, and fossil-fuel divested accounts.

Investment Fund and Investment Account are clarified terminology from the quarterly report format introduced in 19Q2, which the online document at tinyurl.com/spfc-report-guide describes in detail.

In the future a donor's name will only be associated with those funds if the donation equals or exceeds \$20,000.

## ATTACHMENT D

Treasurer's Report September 16, 2020

We're seeing continuing growth in revenue through the end of August – 15% above the seasonally adjusted average. Translated to dollars that's \$110,055.92.

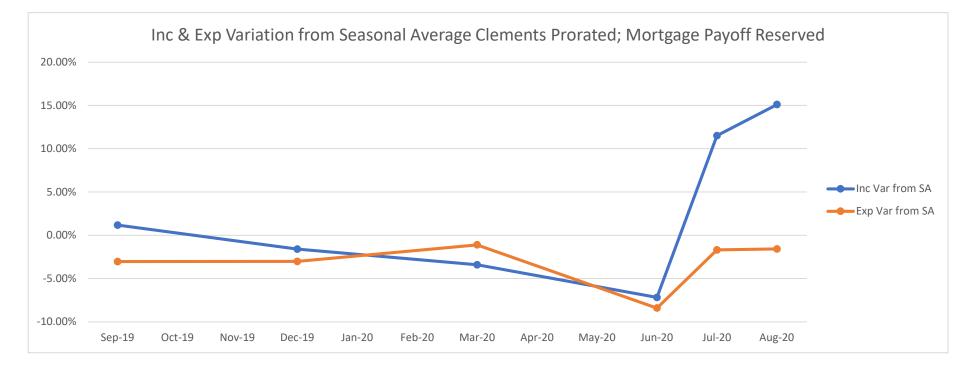
On the Expense side we are seeing a slight increase of the comparison to the seasonal average – from - 1.69% at the end of July to -1.58% at the end of August. Still below the seasonal average – translated to dollars that's 12,302.78 below the average.

There are a couple of concerns on the expense side. We've seen a big growth in spending for Religious Education. We were at -1.76% at the end of July. Spending increased from 4,103.18 in July to a total of 10,276.33 by the end of August.

In addition, we had an unexpected and unbudgeted expenditure of \$500 in a new category called "Additional Ministry-Consulting & Implementation". We need to be careful about this, especially this year.
