Campus Ministry. Memo from Susan Blake

Reverend Mary Ann Macklin submitted the following information for the minutes on the Campus Ministry budget.

Our campus ministry program budget this year has been used on membership dues and participation fees in CaRLA (an interdenominational religious leaders' group), copies, supplies for worship, and social events -- a lock-in during the Holiday Bazaar and two pizza and movie nights at the church. In total (including \$24 in receipts not yet submitted), we've spent \$438.40, just under 10% (9.6%, to be exact) over our budget.

Our Campus Ministry program is growing under the leadership of our Campus Ministry Coordinator, Susan Blake. The program now has about 30 active members and our program is now represented in such campus groups as the Campus Religious Leaders Association (CRLA). As a result, the current budget has been stretched and recently met its limit for the year. In speaking with Susan Blake and the Committee Chair, Katie Peebles, the spending has not been frivolous but rather a product of accommodation to numbers and visibility (curricula, songbook, CRLA dues, and activities). While the group may look into fundraising, are there other ways they can be financially supported in their success? Thanks, Mary Ann
