Walt's leadership in helping supervise the construction of our new Meeting Room 10 years ago, and Tommie's creativity in helping design and make the congregational quilt now hanging in our Library, are just two examples of ways they have helped our congregation. Walt also designed and built all the cabinets in our kitchen, our sound cabinet, and the pulpit which graces our Meeting Room, including carving by hand the chalice mounted on the front of the pulpit. A special plaque will commemorate the naming of The Owens Kitchen.

### D.C. gay marriage law signed at Unitarian church

Interfaith clergy coalition mobilized to promote same-sex marriage in nation's capital.

History was made Friday, December 18, when Washington, D.C., mayor Adrian M. Fenty signed a bill in the sanctuary of All Souls Church, Unitarian, legalizing same-sex marriage in the District of Columbia.

The law was approved by the D.C. City Council December 15.

The Rev. Robert Hardies, senior minister at All Souls, is co-chair of D.C. Clergy United for Marriage Equality, one of the groups instrumental in securing the law's passage. "I applaud Mayor Fenty and the D.C. Council for standing on the side of love and ending discrimination against gay and lesbian Washingtonians," he said in remarks during the signing ceremony.
