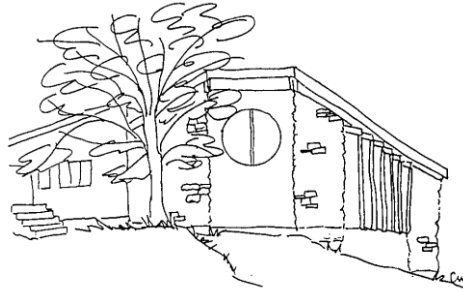

The tragedy in Haiti, like others before it, exposes the misplaced priorities that result in the President of the United States promising \$100 million in relief for Haiti and three hundred times that, \$30 billion, as an extra appropriation for war. The common foes of poverty, disease, hunger and climate change demand the abolition of war in this new century. We cannot save the world and destroy it at the same time, and saving it is much cheaper. Working for peace has never been more important than now.

Reverend Macklin and I are honored to serve a generous community. Last Sunday we received an offering for Haiti totaling \$3,620.42. ## About the Congregational Poll on January 24

On Sunday, January 24, the members of the congregation will be asked to vote in a poll of the Unitarian Universalist Association. We are asked whether we vote "Yes," "No," or "Abstain" to moving the Draft Statement of Conscience on Just Peacemaking to the final agenda of 2010 General Assembly. At a meeting on January 17th, the Just Peace Task Force unanimously voted to recommend that the congregation vote "No." The draft is very similar to last year's draft, which was rejected by vote of the General Assembly. In our view, it shirks the challenge of working courageously toward non-violence and instead accepts war provided it is undertaken in the name of self-defense or humanitarian intervention. Since virtually every war in history is undertaken for supposedly just cause, this looks like a blank check in the absence of limits such as limiting war to territorial defense and insisting that intervention be under United Nations command and be governed by international law. Because the amendment process made little difference to last year's draft and the Commission on Social Witness declined to make major changes following the rejection at 2009 GA, we recommend a "No" vote. We think it better to make no statement than to issue an equivocation and call it a Statement of Conscience.

Upon the death of our son Robert in 1986, church members contributed funds for his memorial. Duba and I also contributed to it. The church designated the Special Purposes Committee to determine the use of the Robert Carter Memorial Funds. This committee then requested Robert's parents to recommend a use. The selection and scheduling of these visits was appropriately determined by the Ministerial Committee of the church.

I am very pleased with the administration of that fund, and I am surprised that the fund has not been expended before the recent visits. I view this project as a cooperative venture in giving and decision-making, and I thank those who participated.

## Feasibility Study Progress

The Green Spaces Initiative provided an update of this building renovation project at our December congregational meeting. Following the wishes expressed by the congregation last June, we have been moving toward the completion of a feasibility study to evaluate our fundraising goals and overall plans. We also applied for and received a grant from the Center for Congregations totaling \$14,400! This money will defray the costs of the feasibility study and architect fees. After researching our options, we selected Jessica White and Associates to conduct the study. We've met with them several times to outline our needs and create interviewee lists. Interviews are taking place this week (even as I write this) and we expect to have preliminary results in February!

If you were not selected for an interview, you should not feel that your input is less valuable or desired. Feasibility studies are costly and we could only interview a tiny handful of the people whose opinions and contributions mean so much to this church and to an improvement project such as the Green Spaces Initiative. ## Nursing Home Advocacy Training February 18 and 25

Our Elder Focus Task Force invites you to a training on February 18 and February 25, 1:30-4:30 p.m., on advocacy for nursing home residents. Are you interested in learning about how to advocate for elders living in care facilities in our community? If so, Ashley Hillman, Long-Term Care Ombudsman and Deputy Director of Area 10 Agency on Aging will be teaching skills necessary for providing that service. A long-term care ombudsman is an advocate for residents in both assisted-living and long-term care facilities. There is no fee or future obligation for this training.

In our Unitarian Universalist movement, we are always looking for new ways to Stand On the Side of Love. We believe this training is one opportunity to learn ways to help some of those who have been marginalized in our society.

The training will be educational. For those who are interested, this training can also lead to becoming an ombudsman volunteer. These volunteers regularly visit with residents at a facility, observe and help resolve issues and complaints. The ombudsman volunteer visits a facility at least once every two weeks, and meets with Ashley once a month to discuss issues as well as listen to guest speakers who provide information about aging, medications, and dementia/Alzheimer's. 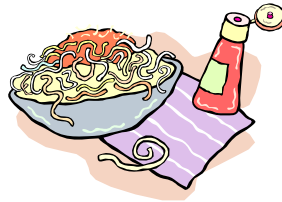
