**2017 Holiday Art Fair and Bazaar**

The Unitarian Universalist Church of Bloomington will hold its 60<sup>th</sup> annual Holiday Art Fair and Bazaar on December 1 and 2, 2017. We invite you to apply to this very special, juried Art Fair! There will be room for 30 artists in the Meeting Room and the hallway of the church.

Booth spaces will be approximately 9 ft. wide by 6½ ft. deep, with some slightly larger where possible. Artists must provide their own display; no work may be hung on the walls. Electricity will be available in every booth; artists should provide their own extension cords and lighting fixtures. A chair will be provided in each booth.

*Set-up is Thursday, Nov. 30, 5-9 p.m. The Bazaar be open Friday, Dec. 1, 10-7 and Saturday, Dec. 2, 9-4.*

**ELIGIBILITY: all work must be original by the artist.** No work made from commercial kits or plans will be considered.

All applications **MUST** be accompanied by a CD showing three images representative of the work you plan to show at the fair. Participants will be chosen for quality of work, originality, and show balance. Suggested art forms include fiber, clay, wood, glass, jewelry, leather, photography, painting, basketry, and mixed media.

**DEADLINE for applications is Friday, September 8, 2017.** Please see the enclosed application for details. Notifications will be sent the first week in October.
