Custodial services budget overage

We are overbudget for Custodial services because of increased church programming. We have been averaging \$1525 per month so far this year and we are just budgeted for \$1243 per month. We currently only have funds (\$2722) to barely cover March and April. We will need at least \$3000 added to this line, which does exceed 10% of the line, which would be \$1492. The total line is 14922.00. \$3000 would cover it, but \$3500 would provide a nice cushion. The Board cannot fix this since it is such a large amount, and the June congregational meeting is too late.

Add the following as an addendum to Policy 5.01 Assistance to the indigent to encompass material assistance:

For the protection of the Church staff, the Board prohibits representatives of the Church from giving money or other material assistance to those who come to the Church seeking help, except in response to a church sponsored program. (Board Minutes 3/19/08)

Rationale: The Church wishes to provide assistance to those in need; however the Church does not have the staff or other resources to provide emergency cash or other material assistance to those who seek help.
